Towards evaluation of trends and high floods contribution to the sea level oscillations in the North Pacific

Sea level observations in the North t Pacific from the marigraph stations of the JASL system and satellite altimetry data from ERS-1/2, TOPEX/Poseidon, Jason-1, Envisat, OSTM/Jason-2 were analyzed. The estimations made on the basis of JASL data demonstrate general rise of sea level over the 23 years period: 47 mm according to linear trend model (with rise velocity of 2mm/year) and 41 mm in quadratic trend. Spatial distribution of linear trend parameters estimated from satellite altimetry data shows general sea level rise for major part of the studied basin with different velocities in different regions and maximum value of 36 mm/year. There exist regions with negative trend where sea level is receding. Regions with positive trend are isolated and mostly distributed in Kurosio current domain and , partially, along 550 LN in the Aleutian Current domain. Isolated regions with negative trend were found near northern part of Kurosio and Aleutian currents and are frequent in major part of North-Pacific current domain.

It was shown that global warming and mean sea level rise do not influence on the rise of repeatability of sea level elevations over the average one and on the rise of repeatability of high floods. Also, the estimations of statistical validity of sea level elevations from JASL coast stations data are given.
