ELECTRIFICATION PLAN (GOELRO) AS AN EXAMPLE OF NATIONAL TECHNO-ECONOMIC STRATEGY

Russian present-day reality dictates the necessity of elaborating an efficient techno-economic strategy, which would coordinate the activities of numerous national economic objects in a rational direction. This is why the particular interest presents the historical and economic analysis of GOELRO: State Commission for Electrification of Russia. The article contains a description of massive preliminary works which became the basis for rational compiling of the GOELRO plan – the work of the GOELRO commission as well as the work of country's natural resources commission which assessed the resources potential of USSR's economics. It also contains the analysis of correctness of plan compiling as well as the specifics of its implementation in particular institutional conditions of plan-based economy. The emphasis is made on the importance of detection of the fields that play the key role to the national economic system on the whole and the necessity of their paramount development. This thesis is supported by the example of implementation of the GOELRO plan.

The article deals with the philosophical anthropology of Pitirim Sorokin. EFFECT OF CHANGES IN LEGISLATION IN THE FIELD OF STATE REGULATION OF NATURAL MANAGEMENT AT THE EFFICIENCY OF WATER PROTECTION MEASURES

The article presents the results of a study to reduce the impact of the quality requirements for wastewater coming from centralized sewage systems users on the efficiency of wastewater treatment plants served by WSS. Constructed the math models of water treatment efficiency are based on results of chemical analysis by 14 ingredients before and after treatment. The models are based on non-linear dependence of the efficiency of the hydraulic load and specific mass of waste in water. For one of the most common WSS utilities in conditions of the Lenigrad region revealed that 3% of centralized sewage systems users are suppliers of more than 90% of waste waters. Determine the percentage of reduction of water pollution, discharged with wastewater, resulting in lessening of their concentrations in the water entering the treatment.

WATER RESOURCES OF EUROPEAN RUSSIA AND THEIR CHANGES IN THE MODERN PERIOD

Conditions of formation of a river runoff within the European part of Russia are considered. Data on genesis of waters of the largest rivers of the studied territory are provided. It was revealed that the main role in changes of a runoff in time belongs to rainfalls which are dropping out when passing over river basins of the Atlantic cyclones. Distribution of a runoff across the territory of the European part of Russia is described, periodic components of long-term fluctuations of river waters are investigated. DIATOMS IN TRANS-ONEGA MODERN LAKE SEDIMENTS: PALEOECOLOGICAL AND PALEOCLIMATIC RECONSTRUCTIONS.

The surface bottom sediments from two small lakes of the Lake Onega area, lakes Palozero and Syargozero, were studied for the first time by diatom analysis. The compositions of the diatom complexes show that the timing of sedimentation in both lakes falls into four diatom zones consistent with their evolution stages. Dominant diatom complexes, from which the ecologo-geographic depositional environment of sapropels and environment parameters were reconstructed and the water levels of the lakes were found to vary asynchronously, were specified for each zone. Diatom flora was shown to respond in different ways to variations in the humidity and dryness of the climate associated with the natural characteristics of the lakes and similarities and differences in their evolution. The climate in the present epoch clearly tends to get warmer.
